Further, the norms and standards followed as per the above said Rules are given in the Annexure.



ANNEXURE

1. The norms of land to be made available is as per the scale :
1 hectare for Pre-primary/primary, 1.5 hectare for Middle, 2 hectares for High/Hr.Sec schools.
2. The Puducherry Right of Children to Free and Compulsory Education (RTE) Rules, 2011, which has come into force in the U.T. of Puducherry, in addition to the already existing Pondicherry School Education Act and Rules, specifies the following norms and standards for a school building :
All-weather building consisting of-
 - (i) At least one class-room for every teacher and an office-cum-store-cum-Head teacher's room;
 - (ii) Barrier-free access;
 - (iii) Separate toilets for boys and girls;
 - (iv) Safe and adequate drinking water facility to all children;
 - (v) A kitchen where mid-day meal is cooked in the school;
 - (vi) Playground;
 - (vii) Arrangements for securing the school building by boundary wall or fencing
3. The school buildings or other structures or the grounds are used only for the purposes of education and skill development.
4. No other school or institution of any kind should function within the school compound.
5. A suitable playground for the purpose of games and sports and materials of such games and sports, should be provided.
6. The managements shall provide sufficient electric fans and tube lights in each classroom to ensure proper ventilation and light to the students.
7. The managements shall provide sanitary and drinking water facilities minimum sanitary facilities for schools (for pupils), as per the MHRD guidelines :
"Separate toilets for boys and girls, with one unit generally having one toilet (WC) plus 3 urinals. The ratio to be maintained is preferably one unit for every 40 students."
8. The Heads of schools should maintain the student strength not exceeding 40 for the classes from I to V and 35 for the classes from VI to VIII in each section.
9. Rainwater harvesting structure should be established in the School building.
10. No class shall be conducted in thatched/other flammable roof sheds.
11. The roofing of the school building should be constructed only with RCC roofing and not by any other roofing. Asbestos sheet roofing / tin sheet roofing should not be provided.
12. Classes upto Third Standard must be conducted in the Ground Floor only, as per the G.O.Ms. No. 80 dt.26.07.2004.
13. The schools should have sufficient fire fighting equipments and water storage facilities.
14. There should be atleast one entry gate and one exit gate in all schools.
15. The entrance/exit gates, the staircase and the verandahs/internal pathways of the schools should be sufficiently broad.
16. The Heads of Institutions shall be personally responsible for the compliance of the directions issued vide G.O. Ms. No.80 dated 26.07.2004.
17. The management shall comply with the instructions issued from time to time by the Director of School Education, in the interest of School Education.
18. The Heads of schools should provide the prescribed the minimum space per pupil as per the following norms:
